Terms and Conditions

Welcome to MTNL Mumbai Email services. MTNL Mumbai provides e-mail services pursuant to the terms and conditions set forth below. By using MTNL Mumbai Email services, you are agreeing that you are legally competent and eligible to enter into this Agreement in accordance with the applicable laws and to use the Services in a manner consistent with the terms and conditions of this Agreement, Privacy Policy and with all applicable laws and regulations.

- 1. MTNL Mumbai provides Email services free of cost on a complimentary basis, only to MTNL Mumbai Customers, who are using various Internet access services provided by MTNL.
- 2. No. of free Email accounts depends on the plan of the service availed.
- 3. MTNL Mumbai Email service account is associated with the Internet service plan subscribed by the customer, and Email account will also be terminated if subscription to Internet service is terminated by the customer.
- 4. Mail Storage: The Service includes a maximum of 100 MB of free e-mail storage per Email Account. Further, any individual e-mail message larger than 20 megabytes may or may not be processed. All MTNL Mumbai Email users are advised to download all mails, contacts, files, folders to their local Computer storage regularly by using Email client software such as Microsoft Outlook, Mozilla Thunderbird etc.. You agree that MTNL Mumbai will not be responsible for any data loss arising out of any unforeseen incident such as software corruption or storage hardware failure etc.
